





the year in review

This past year, Denver Art Museum visitors came face to face with American icons like Benjamin Franklin, took a trip down memory lane via psychedelic rock posters, and soaked in the vibrant landscapes of New Mexico, as well as enjoyed tours, events, and activities designed for everyone from toddlers to teens to teachers.

"The museum worked diligently this year to adjust to a challenging economy and preserve the broad program offerings our visitors have come to expect," said Director Lewis Sharp. "Fall 2008 saw an incredible trio of exhibitions including the debut American museum exhibition for German artist Daniel Richter; Houdon from the Louvre, the second exhibition from the collaboration with Atlanta's High Museum and the Musée du Louvre; and a celebration of southwestern painter Ernest Blumenschein. These exhibitions, in conjunction with programs like studio classes and school tours, highlighted something new each visit."

The early part of the year also brought administrative changes, as modern and contemporary curator Christoph Heinrich was named Deputy Director. In addition to his new role, Heinrich continued to spearhead the evolution of *Embrace!*, one of the most ambitious contemporary exhibitions in the museum's history.

"From the moment of my first visit for the opening of the Hamilton Building, I began envisioning a project where artists could take over the unique spaces of the museum," said Heinrich. "The building was conceived by an artist, for artists, and I was eager to see what creative sparks could fly when artists and architecture merged."

In March, the museum kicked off its fourth season of *Untitled*, the final Friday program featuring unique and offbeat encounters with art. The list of community partners associated with *Untitled* continued to grow, and themes like *Untitled #20 (Trip)* and *Untitled #24 (Crossbones)* served as worthy vehicles for unconventional and unexpected art experiences for visitors. *The Best Spring Break Ever* welcomed thousands of kids and their grown-ups to the museum for two weeks of hands-on activities. Spring also saw the launch of Create Playdates where the toddler set had an opportunity to drip, splatter, and draw.

The Psychedelic Experience: Rock Posters from the San Francisco Bay Area, 1965–71 was the most comprehensive exhibition of psychedelic rock posters ever presented at an art museum. Derived from a collection of about nine hundred posters the museum acquired earlier this year, this exhibition and Psychedelic Side Trip, the interactive programming area that accompanied it, was a favorite among locals and tourists of all generations and created fantastic energy well into the summer.

"The museum's galleries were constantly changing this year, and our ability to show more of the collection expanded through the introduction of new galleries including the Walter + Mona Lutz Gallery dedicated to the display of bamboo objects on the museum's Asian floor and the reopening of the western American collection also in the North Building," said Heinrich.

Acquisitions helped spur additional gallery changes this year including the works-on-paper installation *Drawings, Anyone? Recent Acquisitions from the Eleanor and Henry Hitchcock Foundation*, inspired by more than forty works from the Hitchcock Foundation donated over the last two years, and *Fritz Scholder: A New Indian Image* in the American Indian galleries, which featured the newly acquired painting *Seated Indian with Rifle*.

New education initiatives included the launch of the website creativity.denverartmuseum.org. The site uses the museum's collection as a resource for teachers of diverse subjects including history, geography, art, and culture. The museum maintained focus on scholarship resulting in publications and gatherings over the course of the year. The Mayer Center for Pre-Columbian and Spanish Colonial Art held its ninth-annual symposium, and the Petrie Institute of Western American Art hosted its third national symposium thanks to the leadership of Peter Hassrick. Hassrick retired as director of the institute in April, but he continues on as Director Emeritus for the department.

"The museum benefitted from the continued support of an extremely dedicated board of trustees this year, and we were saddened by the loss of our friend and fellow trustee Peter Dominick," said Chairman Frederic C. Hamilton. "Peter's advice and expertise were a valuable resource throughout the Hamilton Building project, and we appreciate his commitment to the museum and this community."

In April, Cathey McClain Finlon agreed to step away from her post on the board of trustees in order to become interim president and focus on developing and leading the process of finding a successor for Director Lewis Sharp.

"After twenty years in the role of director, Lewis was ready to turn the museum over to new leadership," said Hamilton. "Fortunately, we have a very capable and dedicated board, as well as Cathey Finlon, to help with the arduous process of finding someone worthy of replacing him. Thanks to Lewis's recommendations, combined with the insight of Cathey and the board of trustees, we agreed we had inside the organization a real future leader in Christoph Heinrich."

Sharp's retirement at Collectors' Choice in December coincided with the announcement of Heinrich as the new Frederick and Jan Mayer Director of the Denver Art Museum.

"Lewis was the greatest leader for the Denver Art Museum and the community at large over the last twenty years," said Hamilton. "The trustees are confident that the positive momentum Lewis achieved will be carried on by Christoph Heinrich, and we look forward to an exciting future."

"It was a difficult thing to think about leaving the Denver Art Museum," said Sharp. "The trustees, donors, and staff were friends and family to me. The appointment of Christoph Heinrich as my successor gives me incredible confidence in the future of the museum. I look forward to becoming one of its most enthusiastic supporters."



Long before Lewis Sharp transformed Denver's art scene as Director of the museum, he had a distinguished career as a curator and scholar of American art. He has a particular interest in the work of American sculptor John Quincy Adams Ward who was the subject of Sharp's dissertation. Ward cast his most famous work, Indian Hunter, in the 1860s. The bronze sculpture was later purchased by a group of wealthy New Yorkers and placed in Central Park. This smaller version was recently acquired in honor of Lewis Sharp's twenty years as director of the Denver Art Museum.







development report

On behalf of the board of trustees, the development committee gratefully acknowledges the generous contributions of our donors and members who supported the museum in 2008–2009.

This was a tremendous year for the Denver Art Museum with exciting exhibitions and rotations that showed great diversity and broad appeal. From the western American art of Ernest L. Blumenschein to the rock-and-roll memories of *The Psychedelic Experience: Rock Posters from the San Francisco Bay Area, 1965–71* to the opening of the Lutz Bamboo Gallery, the Denver Art Museum continues to delight and inspire.

The Denver Art Museum received generous gifts from the foundation community, most notably Morgridge Family Foundation in support of Creativity Resource, a standards-based tool for teachers; Helen K. and Arthur E. Johnson Foundation in support of *The Masterworks of Charles M. Russell*; William Randolph Hearst Foundation for its educational endowment at the DAM; and True Foundation for its support of *Allen True's West*.

The museum received continued funding from the citizens who support the Scientific and Cultural Facilities District and from Target, for the museum's Free First Saturday program. 

treasurer's report

The Denver Art Museum carried out its mission of acquiring, interpreting, and preserving art during fiscal year 2009 with a general operating budget of \$18.4 million. While resourceallocation refinements were made during the course of the year as management pursued reorganization efforts to improve efficiency, the Denver Art Museum fiscal year ended 2009 with annual operating revenues exceeding annual operating expenses.

The abbreviated general operating financials shown below reflect fiscal year 2009 year-end results for the Denver Art Museum's general operating fund:

When consolidating the Denver Art Museum's overall financial condition, it is necessary to apply accrual accounting principals at the conclusion of each fiscal period in preparation for the annual certified public accounting firm audit. During fiscal year 2009, these adjustments impacted the stated net asset valuation of the Denver Art Museum. Examples of such entries include adjustments for the change in net assets held by the Denver Art Museum Foundation* for the benefit of the museum, depreciation associated with certain property, plant, and equipment owned by the museum, and acknowledgement of the present value of intended future donor contributions. The Denver Art Museum's consolidated audited statement of activities for the fiscal year ended September 30, 2009, is shown to the right.

In summary, the Denver Art Museum concluded the 2009 fiscal year with consolidated financials reporting a decrease in net assets of approximately \$6.3 million.

The primary fiscal goals for the future remain preserving core mission operations, managing resources to annual projected revenue, and ensuring the future stability of the institution.



*The Denver Art Museum Foundation (the Foundation) is a separate, tax-exempt Colorado nonprofit corporation formed to hold, manage, invest, and administer substantially all the museum's endowment funds exclusively for the benefit of the Denver Art Museum. The Foundation is governed by its board of directors, and the Foundation has legal title to and controls all funds within the Foundation, subject to any restrictions imposed by donors, until such funds are distributed to the museum by resolution of the Foundation's board. The Foundation's bylaws preclude the use of such funds as security for any obligation.

The Foundation's bylaws also provide for an annual distribution to the museum of up to four percent (increased to five percent for fiscal year 2009) of the fair market value of Foundation net assets, not including pledges receivable, for the current year and the two prior years. The calculated distribution for 2009 was \$4,242,314 and was received subsequent to year end. Accordingly, the distribution amount is recorded as a distribution receivable from the Foundation at September 30, 2009.

*To meet the Internal Revenue Service's annual information return, the museum must make certain adjustments to its reported change in total net assets. Examples include the exclusion of the Foundation's change in net assets, the inclusion of depreciation, and the impact of investment income and pledged in-kind services. For purposes of the museum's Form 990, the certified public accounting firm has estimated the change in net assets to be an increase approximating \$57,000.
